STANDING COMMITTEES

2023 Budget, Lisa Darrah – No report

Camp O'Bannon, Kerri Postle: Kerri reminded members to sign up for the following volunteer slots via Sign-Up Genius – 1) Wednesday Ice Cream Bar at Camp. Velvet is donating 2-3 gallons of ice cream per week and selling any ice cream needed after that at cost and we will need to supply toppings. 2) Camp Clean up on Saturday, June 3rd, and Monday, June 5th. We will be cleaning the cabins on Saturday and donuts will be provided. On Monday (prior to a shortened meeting), we will be making the beds up and planting flowers. Pizza will be provided for dinner. 3) Help with Laundry on Saturdays. The sign-ups for this are going well; only a few slots left. 4) Camp Supplies. Registration will be at Camp this year on Monday, Wednesday and Friday at the end of April. Ted is not sure if he will need help with registration...more to follow.

Kerri has researched the purchase of 60 towels and 60 blankets for camp (15 each per cabin). The bath towels will run approximately \$450.00. The best blanket option is a fleece blanket that will run about \$1,200.00...combined cost, with tax, will come under just \$2,000.00. Motion was made by Joan Bankes to approve up to \$2,000.00 for the purchase of 60 bath towels and 60 fleece blankets for Camp O'Bannon. The Funds are to come out of the Foundation Account. Motion seconded by Robin Nikolovski. Motion carried. Kerri will make arrangements for the purchase of the towels and blankets and delivery to Camp.

Computer, Paula McWilliams: Paula reported that she set up multiple Sign-up Genius sign-ups for the Club this month. If you are not able to access, or didn't receive them, please let Paula know as soon as possible. She advised that the Paint-n-Sip Fundraiser only has two slots left. Paula also advised that she is working on a new information brochure that she hopes to have completed next week. Lisa thanked Paula for all her hard work this month.
