The General Account is used for our day-to-day general operations (i.e. postage, stationary, PO Box rental, etc...). The Foundation is a 501c3 and has two accounts - the checking account and the Trust account. All of the fundraisers are run through the Foundation checking account. Kerri also contacted Venmo about running fundraiser payments through a Venmo account. Unfortunately, at this time we could only accept donations through the account where nothing was received in return. For example, if someone just wanted to make a $\$ 500$ donation, that could be done. However, if they wanted to pay for a golf outing entry fee, the Venmo account could not be used for that. It is something they might be researching and changing in the future. In the meantime, fundraiser payments may be made via cash, check or credit card...Kerri advised the check to Licking Memorial Hospital in the amount of $\$ 2,000$ has been delivered for the purchase of stuffed animals.

Corresponding Secretary, Cindy McCracken: Cindy reported that we received a note from Doris Spriggs...just wanted to say "hi". She wanted everyone to know that she is adjusting well to Florida and that she misses us.

## 2023 Budget, Lisa Darrah - No report

Camp O'Bannon, Kerri Postle: Kerri advised that there was a Camp Board meeting on April $26^{\text {th }}$.
